February in Texas is a transition to Spring!

Start planning for a beautiful spring landscape now. In North Texas the weather is variable, but we almost always get some nice days to work in the yard and cure your gardening spring fever!

- Put Pre-emergent on your lawn to prevent cool season grassy weeds from sprouting.
- Prune Trees, Roses, and Shrubs
- Clean up leaves and any dead plant material
- Prune crepe myrtle seed pods, but don't top them (Crepe Murder)
- Plant bare root perennials and summer flowering bulbs as soon as ground is workable
- Best time to fertilize trees
- Once freezing weather has passed cut lawn to stimulate growth
- Inspect sprinkler system for leaks and time settings
- Sprinklers can still be in the off position and only water when there is a shortage of rain. Please conserve water whenever possible.

During leap years, an extra day added to the calendar to help synchronize it with Earth's orbit around the sun and the actual passing of the seasons. Why do we need these extra days?

Earth's orbit around the sun is 365.25 days. That's why we need a leap year every four years. The reason is that Earth takes approximately 365.25 days to orbit around the sun every year. It's that .25 that creates the need for a leap year every four years.

During non-leap years aka common years – like 2014 - the calendar doesn't take into account that extra quarter of a day actually required by Earth to complete a single orbit around the sun. In essence, the calendar year, which is a human artifact, is faster than the actual solar year, or year as defined by our planet's motion through space.

Over time and without correction, the calendar year would drift away from the solar year and the drift would add up quickly. For example, without correction the calendar year would be off by about 1 day after 4 years. It'd be off by about 25 days after 100 years. You can see that, if even more time were to pass without the leap year as a calendar correction, eventually July would be a winter month in the Northern Hemisphere.

During leap years, a leap day is added to the calendar to slow down and synchronize the calendar year with the seasons. Leap days were first added to the Julian Calendar in 46 B.C. by Julius Cesar at the advice of Sosigenes, an Alexandrian astronomer.

In 1582, Pope Gregory XIII revised the Julian calendar by creating the Gregorian calendar with the assistance of Christopher Clavius, a German mathematician and astronomer. The Gregorian calendar further stated that leap days should not be added in years ending in "00" unless that year is also divisible by 400. This additional correction was added to stabilize the calendar over a period of thousands of years and was necessary because solar years are actually slightly less than 365.25 days. In fact, a solar year occurs over a period of 365.2422 days.

Hence, according to the rules set forth in the Gregorian calendar leap years have occurred or will occur during the following years:

Notice that 2000 was a leap year because it is divisible 400, but that 1900 was not a leap year. Since 1582, the Gregorian calendar has been gradually adopted as a 'civil' international standard for many countries around the world.

An extra day added to the calendar every four years at leap year helps synchronize the calendar year with Earth's orbit around the sun. The extra days are added in accordance with standards set forth by the Gregorian calendar system, which is widely used in many countries around the world.

2016 is a leap year!!



3 Secrets to Lowering Your Property Taxes

Everyone likes a tax break, and you may be in line to get one. If you have already received your assessment notice, you may have to wait for next year. But there are still ways that you can lower your property taxes for this year. Keep reading!

#1: Appeal Property Assessments

Think about this revealing fact: between 30% and 60% of homeowners are paying a higher property tax rate than they should because of a bad property assessment. Yet only 1 in 10 homeowners ever contest that assessment.

#2: Tax Credits for Certain Improvements (Think Green)

An indirect way to reduce your property taxes is to offset them with tax credits. You would be amazed at how much money homeowners leave with the IRS at the end of each year simply because they did not claim all of the credits due to them.

If you make certain improvements to your home that fall into one of these categories, you could offset your property taxes by hundreds if not thousands of dollars. Here are three homeowner tax credits available to you:

- Home Improvement Loan Interest. Any home improvement loan of \$100,000 or less is tax deductible.
- Energy-Efficiency Tax Credit. Simple improvements like installing new efficient windows, HVAC, insulation, or storm doors can account for up to \$500 in tax credits.
- Renewable Energy Tax Credit. Green improvements like installing solar panels that supply your home with energy gives you a tax credit of 30% of your costs for buying and installing.

These tax breaks may change frequently, so consult a tax professional to discuss what is available to you.

#3: Take Advantage of Tax Breaks

Finally, in addition to these measures, standard run-of-the-mill tax breaks can save you a lot of money. You need to bone up on the different credits afforded to you as a homeowner. Association Members:

By now you should have received your statement for the 2016 Homeowner's Association Assessments. As managing agent for Mira Lagos Homeowners Association, FirstService Residential hereby notifies you that the Board of Directors has approved the 2016 Operating Budget. Due to the increasing landscape contract costs, utilities, and our desire to continue to make Mira Lagos an outstanding community, the assessment rate for 2016 has increased 10% per the governing documents.

The payment due date is/was January 30th, 2016. If you were unable to make full payment by that due date please email the onsite office to stop the late fees and interest payments and get set up on a payment plan for a \$50.00 fee. Spread the payments out if needed for 4-6 months.

Timely Assessment Payment Saves Us All Money!

In order to meet its financial obligations, our association depends upon the timely receipt of our monthly assessments from the owners.

When our community's budget is approved by the Board, it assumes two things: the amount of income must equal the amount of expenses, and, that each homeowner will pay his or her maintenance assessment in a timely manner. If one or the other fails to happen, we have a cash-flow problem and it usually results in costing all of us more money in the long

Our community depends entirely upon the monthly assessments to pay its bills (insurance, landscapers, water, electricity, gas, management, etc.). Whenever homeowners are delinquent in paying their assessments it creates a "cash-flow shortage" that may prevent the association from paying it's bills in a timely manner. There is no other source of income available to make up for the shortage. If we "borrow" money from the reserves to pay for operating expenses, we are required to pay it back, thus we create even more expenses. Ultimately, when even a few homeowners fail to pay their assessments on time it ends up costing us all more. That is because since most of our expenses are pre-determined, the only way to make up for a cash-flow problem is to increase the amount of money coming in, or in other words, raise our monthly assessment amount.
